### **Section A: JOINTLY DEVELOPED**

Edward Gideon Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

*Parents are involved in the development of this policy by attending SAC/Spring Title I Parental Input Meetings. Parents were invited to take part via a calendar reminder and a flyer, as well as by verbal invitations. During the meeting, held this year on 4/18/23, parents were given the opportunity to provide input and suggestions related to the parent and family engagement programs as well as the development of the parent and family engagement policies, workshops, and programs.*

### **Section B: ANNUAL TITLE I MEETING**

Edward Gideon Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

*The Annual Title I meeting to inform parents of the requirements of Title I and the school's participation as well as the parents' rights to be involved is held during Back to School Night, which is scheduled for September 14, 2023. At this meeting, the Principal or their designee, will provide parents with information about the requirements of Title I part A, parent rights to know, state content standards and academic assessments, how to track student progress and to work with educators.*

*For students in grades K through 8, the Parent and Family Engagement Policy will be included in a pre-printed folder and distributed to all parents at the beginning of the school year. The folder will be used to share communications about upcoming parent meetings and events with parents.*

*SAC Meetings are held monthly, with meetings varying in times (9:15 during school hours, 6:00 after school hours). Family Night events and Back to School Night are held in the evening. Winter and Spring Title I Parental Input meetings are held in the mornings at 9:15 or 6:00 to maximize parental involvement.*

*Monthly Calendars and flyers are created and sent home to parents to inform them of upcoming school events including but not limited to Back to School Night, Report Card Conferences, Parent Workshops, Family Night, and other activities to parents in a format, to the extent practicable, and in a language that parents can understand.*

*All communication is sent home to families in parent-friendly language and translations into multiple languages is available through the district's Family and Community Engagement Office, upon request.*

### **Section D: SCHOOL-PARENT COMPACT**

*During a monthly SAC (School Advisory Council) meeting in April, parents, administrators, and teachers will meet to jointly develop the school-parent compact. This year, the Spring meeting took place on 4/18/23. Parents provided input for the compact by sharing ideas on how the school staff, parents, and students will build positive partnerships and help students to achieve academic standards.*

*A Parent Resource table is available on the first floor in the main lobby to provide parents with an area to locate information and to provide parents with an opportunity to learn more about family engagement programs and activities. Kindergarten Open House is held in the Spring, during which time prospective kindergarten parents can visit the school and meet the teachers and staff. During the same week, prospective parents are invited to visit the school and observe the kindergarten classes. "First Mondays" are monthly informational sessions that provide resources from community partners as well as workshops for parents and families. To support our students and families with a variety of services and needs, the community partners include but are not limited to Outward Bound, Mural Arts, PhilAbundance, and HopePHL.*

#### **Section G: BUILDING CAPACITY OF PARENTS**

Edward Gideon Elementary School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

*The Annual Title I meeting to inform parents of the requirements of Title I and the school's participation as well as the parents' rights to be involved is held during Back to School Night. The Principal or their designee will provide parents with information about the requirements of Title I part A, parent rights to know, state content standards and academic assessments, how to track student progress and to work with educators as well as information about the school's curriculum. Monthly parent workshops are held to provide information about Gideon's literacy and math programs, and how they align with the PA Common Core State Standards. One workshop is dedicated to providing information to the parents about the PSSA, the state assessments. All workshops are geared to providing parents with an overview of the programs Edward Gideon Elementary School uses as well as providing materials to parents to implement what they learned at home. At MTSS and IEP meetings parents are shown strategies and given materials to work with their child at home. Parents are invited to learn about the academic progress and achievement of their child. Report Card Conferences will be held in November, February and March. Interim reports will be printed and sent home to parents to inform parents of the academic progress of the students. Interim Reports are available in October, December, February and May.*

**Section H: BUILDING CAPACITY OF SCHOOL STAFF**

Edward Gideon Elementary School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

*School staff will participate in a Professional Development session titled: Working with Parents as Equal Partners. This PD session will take place in Fall of 2023/24 school year. It will include online district training resources developed with parent input. Results of the Title I Parent Survey will be shared with staff to inform staff of how the parents responded to the various questions.*

Edward Gideon Elementary School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

*During monthly SAC meetings, parents may make recommendations regarding parent and family engagement activities. School staff will work in conjunction with the parents to plan and hold the engagement activity as decided upon by the SAC team members.*
